**Excelsior Rotating Public Art Gallery**

The Excelsior Action Group (EAG) is an economic and community development organization whose mission is to revitalize the Excelsior's Commercial Corridor on Mission Street. In response to feedback from the community calling for corridor beautification, EAG plans to establish a rotating public art gallery, consisting of 4'x8' art panels that will be displayed in circulation around the Excelsior community for a term of 3-5 years. Potential locations for panels may include the Excelsior Library, local businesses, and vacant storefront windows. The theme of this gallery rotation is *Green the Excelsior through Art*; art panels will depict artist's interpretations of natural landscapes in San Francisco and/or California. Artists will be expected to participate in 2 Excelsior community meetings, first to hear the ideas of community members and second to showcase their work. This application is open to all professional artists, although those in residence or with a connection to the Excelsior will receive preference. EAG will provide materials for art panel production, and artists will receive a competitive stipend for their time and labor.

**Submission Information**

Deliver one CD with six JPEGs of previous work, along with a corresponding image identification list, resume, 3 references, application form, and an artist statement. Label all materials.

**Check list:**

- Application form, signed (hard copy)
- One CD with 6 JPEGs (images must be labeled in this order: last name, first name, and number)
- Corresponding Image Identification List (title, date, materials, size, and location if applicable)
- Resume including 3 references (references: name & contact info)
- Artist Statement (optional)

Images must be saved PC compatible .JPG files on a CD-ROM at 72 dpi. The maximum pixel dimensions are 1000 in width and 1000 in height. All images must be clearly labeled with the artist's last name, first name, and number. Example: doe\_jane\_01. Do not embed images into a Power Point presentation. Collaborative teams may submit up to four digital images per artist.
